**OSHA 7205—Health Hazard Awareness**

This 1/2 day (5 hour) training course provides an introduction to common health hazards that are encountered in the workplace. These health hazards will include exposure to chemicals, asbestos, silica, and lead.

Upon successful completion of this course, participants will be able to:

- ◆ Identify types of health hazards and sources of exposure;
- ◆ Identify ways to recognize, evaluate, and control hazards in the workplace;
- ◆ Locate OSHA resources on health hazards; and
- ◆ Identify engineering and work practice controls.

**OSHA 7105 Evacuation & Emergency Planning**

This 1/2 day (4 hour) training course will provide detailed information to prepare participants to develop evacuation and emergency planning that focuses on OSHA requirements for emergency action plans and fire protection plans.

Upon successful completion of this course, participants will be able to:

- ◆ State the reasons for emergency action plans and fire prevention plans and identify when they are required for a workplace;
- ◆ Provide elements of a good evacuation plan;
- ◆ Describe features of design and maintenance of good exit routes; and
- ◆ Focus on assessment of risk for terrorist attacks and how to utilize OSHA's two matrices, evacuation planning and fire/explosion, as tools in emergency planning.
